RULES AND REGULATIONS

1. The event will be held annually on the 2nd Saturday of November each year. The date for this year is November 9, 2019.
2. The event is a four county collaborated tourism effort to promote Southwest Georgia.
3. The event will begin at the intersection of GA Hwy 37 and US Hwy 19 in Camilla and end on Hwy 37 at the Georgia-Alabama state line in Ft. Gaines.
4. Each county, city and participant will be responsible for advertising the yard sale to residents in their community.
5. All yard sales **must be visible** from GA Highway 37 (Broad Street in Camilla)
6. Participants will need to obtain permission from property owners or managers to hold their yard sale. A permission slip is included as part of the application and must be completed.
7. **Register your sale with the Camilla Chamber of Commerce.** The City of Camilla requires a permit for yard sales. There is no charge for this permit. However, participants in the City of Camilla registering their sale with the Camilla Chamber of Commerce will be covered under a blanket permit issued to the Chamber for this event. Mitchell County does not require a permit, however we encourage participants to still register their sale with the Camilla Chamber of Commerce so that their sale will be printed on our official yard sale guide.
8. This is **NOT** a money-making project for any **ONE** group. Anyone or any organization participating will retain all proceeds from their sale.
9. This is a **GREAT OPPORTUNITY** for church groups, school groups, and civic clubs to raise funds. Businesses located along the route are encouraged to participate with sidewalk sales. Although permitting is not necessary for these businesses, we encourage them to register with the Chamber so that they will be included on our guide.
10. There is a need for organizations to sell **water, drinks, snacks**, etc., along the route.
11. You do not have to be located on Hwy 37 to participate. Mitchell County High School is offering space rentals in their parking lot for a very reasonable fee. Please call Patricia Ashley at 229-336-0970 to take advantage of this opportunity.
